- NE18515: Development and Evaluation of Broccoli Adapted to the Eastern US, 10/2018

 09/2023 [New Project Request, submitted by Thomas Bjorkman, Cornell and Lincoln Zota, Florida]
 - Expensive faculty are not required for broccoli screening the proposal includes a component about measuring yield
 - No objections to the concept, but the research component should be stronger
 - Are breeders (university based or otherwise) involved?
 - How will the proposal deal with genomics?
 - MAC recommendation: Approve the request to write with revision. The group will be advised to revise the objectives to better address a research component beyond purely screening.

- 1. NE_TEMP1834: *Genetic Bases for Resistance and Immunity to Avian Diseases*, 10/2018 09/2023 [Renewal of NE1334, AA: Robert Taylor-WVU]
 - NOTE: This proposal has been revised in response to peer reviewers' and the MAC's comments from February 2018.
 - Project has a strong, productive history
 - Faculty are well-represented across the region
 - Lots of outputs, the group works well together beyond the aggregation of those outputs
 - Placeholder: NE_TEMP1834 is a strong candidate for the 2019 Northeast Award for Excellence in Multistate Research
 - NERA previously approved NE_TEMP1834 and the OED will send to NIFA for final approval.
- 2. NE_TEMP1835: *Resource Optimization in Controlled Environment Agriculture*, 10/2018 09/2023 [Renewal of NE1335, AA: Adel Shirmohammadi-Maryland]
 - Reviews were generally positive
 - Scientific merit was not emphasized the emphasis was on key areas in the 'controlled environment agriculture' area of focus
 - This group works together in areas where the region needs to have expertise

- Quality will rise and fall based on participation and leadership within the group
- Digital Agriculture / Ag Engineering interface is important for the region
- A motion for the MAC to approve the project was introduced by Gary Thompson, seconded by Eric Wommack, and unanimously approved.
- MAC recommendation: Bring NE TEMP1835 to NERA for approval
- 3. NE_TEMP1838: Development of a Weed Emergence Model for the Northeastern United States, 10/2018 09/2023 [New Project Proposal, AA: Margaret Smith-Cornell]
 - The project seems more targeted to a specific outcome than others
 - Description deals with weed emergence and climate
 - Activities include validating and expanding models for weed emergence
 - Northeast region does have a need for a weed proposal
 - Reviews were split: two reviews gave 'unacceptable' grades and strong criticism on technical merit
 - *i.* Does the team have the capability to build a model beyond those that currently exist?
 - Participation list is strong (representation from around the Northeast, plus Virginia Tech, UC Davis, Indiana, Michigan)
 - MAC recommendation: Return the project to the technical team, have them respond to peer reviews, include on the next MAC meeting agenda
